The following fees apply to all electrical product safety certification applications from the 1st of July 2025. Both languages are equally authentic. In the event of any discrepancy between the two languages, the English description shall prevail.

Services and Fees 服务与收费	
1. New Certificate 新申请	AUD 700+GST
2. Renew of Certificate 更新申请	AUD 700+GST
3. Technical Modification of Certificate 技术性修改申请	AUD 500+GST
4. Non-technical Modification of Certificate 非技术性修改申请	AUD 330+GST
5. Transfer a Certificate to another company 证书持有人变更	AUD 330+GST
6. 24-hour Priority 24 小时加急服务	200% normal service fee
7. 72-hour Priority 72 小时加急服务	150% normal service fee

Notes:

1. Fees are in Australian Dollars. (Additional fees will be charged if payment is not in Australian Dollars.)
2. GST will not be charged to a client outside of Australia.
3. Extra report review fee: Where applications require multiple full test reports, an extra technical modification fee of AUD 500 + GST per report may be applied.
